

HOUSE RULES NOFX IN EINDHOVEN 18 and 19 May 2024

_ – Visitors to this event are not age-restricted. The organization can always ask its visitors to show valid identification. – Visitors must be in possession of a valid admission ticket. – Unauthorized persons are prohibited on all grounds belonging to the festival site and/or parking spaces used for parking by visitors to the event in accordance with art. 461 of the Criminal Code. – In the context of safety, J.O.A/HOSSA BV can search visitors, search (hand and/or back) bags and/or request them to pass through a special detection gate. – Bringing and/or possessing glassware, plastic bottles, cans, fireworks, drugs, similar objects and drug-related objects, (fire) weapons and/or other dangerous objects and/or substances, or food, (alcoholic) drinks and/or (domestic) animals are not permitted at the event location before, during and after events. – Visitors to events organized by or on behalf of J.O.A/HOSSA BV enter the event location at their own risk. The organizer accepts no liability for any damage, for whatever reason, which is the direct or indirect result of actions or omissions of J.O.A/HOSSA BV, of persons in its employ, or of other persons employed by or on behalf of it. or from third parties, during or in connection with the stay at the event location, unless the damage is the result of intent or gross negligence. – Visitors are advised to wear earplugs, which are available at the first aid and the entrance of the event location during events organized by or on behalf of J.O.A/HOSSA BV. – During events, smoking is only permitted at the event location in the designated smoking areas or in the open air. Smoking in tents and under canopies is prohibited. – Threats, theft, abuse, discrimination, sexual harassment and other annoying, provocative and/or offensive behavior and/or attempts thereto by visitors will not be tolerated by HOSSA BV. – Without prior written permission from the organization, visitors are not permitted to hand out promotional material (samples/flyers/merchandise, etc.). – Without written permission from the organizer, visitors are not permitted to make and/or publish video and/or sound recordings (photos and videos, etc.) of their stay at events organized by or on behalf of J.O.A/HOSSA BV. – Video surveillance systems may be installed or otherwise active at various places in and around the event location, with which image and/or sound recordings can be made. Visitors to events organized by or on behalf of HOSSA BV agree to the making of these image and/or sound recordings as well as the publication and reproduction thereof. In the context of public order and safety, these recordings may be shown and/or provided to third parties. – When entering and leaving the event location, visitors must not cause any nuisance to local residents. – Glasses and/or bottles may not be taken outside. – Visitors are obliged to follow instructions, regulations and/or directions from employees of J.O.A/HOSSA BV, the event location, security staff, the police and/or other competent authorities at all times. – The general visitor terms and conditions of J.O.A/HOSSA BV also apply to visits to J.O.A/HOSSA BV events and these house rules. These general terms and conditions can be consulted on the website www.nofxineindhoven.nl and are available for inspection at the entrance of the event location and will be sent free of charge upon request. Visitors who do not adhere to the organization's house rules and/or general visitor terms and conditions may be denied access to J.O.A/HOSSA BV events and the event location without the right to reimbursement of the costs for the admission ticket and any service charges charged. and/or other costs. In the event of an eviction, the associated data is always shared with the local authorities.
